## **School Board FY 2025 Budget Direction**

The mission of Arlington Public Schools is to ensure all students learn and thrive in safe, healthy, and supportive learning environments.

The School Board is committed to ensuring that APS financially supports its mission in FY 2025 by providing a high-quality education to all students while laying the groundwork for success and sustainability in the future.



## **School Board FY 2025 Budget Direction**

The School Board, therefore, directs the Superintendent to prepare a needs-based budget that:

- Aligns to the 2023-2024 School Board Priorities.
- Maintains our commitment to recruit, hire, retain, and invest in a high-quality and diverse
  workforce by sustainably funding market-competitive salary scales and benefits and making
  other investments as needed to provide high-quality service and support to APS staff.
- Limits new funding requests to items specifically delineated in the priorities or those that are necessary for operational success. For all new funding requests, provide the following: rationale; specific, anticipated outcomes; how and by whom the outcomes will be measured; and the timeline for evaluation.
- Begins to implement necessary changes in resource allocation as outlined in the planning factor study, in particular those that align with our priority of investing with urgency to improve educational outcomes for students with disabilities, English learners, Black and Latino, and economically disadvantaged students.



### **School Board FY 2025 Budget Direction**


#### The School Board further directs the Superintendent to:

- Use reserves and strategic reductions to balance APS' immediate needs with long term financial sustainability.
- Provide details for changes in any major expenditure category (FTEs, salaries, benefits, purchased services, etc.), allocations between school based and non-school based positions, and total budget in each category.
- Provide recommendations for strategic changes to service delivery, changes in fee schedules, phased-in additions, and additional measures to balance the budget as appropriate.
- Provide three-year forecasts of revenues and expenditures to gauge long-term financial sustainability.

#### Sept. 30 Enrollment

Sept. 30 Official Enrollment: 27,452 students

Actual enrollment is 3 fewer students than the enrollment of 27,455 for 2022-23.

Additional comparisons with 2022-23 enrollment:

- Pre-K membership of 919 is a decrease of 97 students (9.55%)
- K-5 membership of 12,485 is an increase of 2 students (0.02%)
- Overall PreK-5 membership of 13,404 is a decrease of 95 students (0.70%)
- Middle school membership of 5,875 is an increase of 65 students (1.12%)
- High school membership of 8,173 is an increase of 27 students (0.33%)
- K-12 membership of 26,533 is an increase of 94 students (0.36%)





## **Strategic Plan Update**

#### APS Seeks Feedback on Strategic Plan Draft Mission, Vision, Core Values and Priorities

- Since kicking off our work on the 2024-30 APS Strategic Plan in September, we have heard from over 4,400 students, staff, families, and community members. Initial feedback informed the Steering Committee's revisions to the current APS mission, vision, core values and priorities.
- The draft is now available for the community to review and provide feedback by Sun, Nov. 5. Responses will inform the final recommendation.





# Strategic Plan Goal: Ensure 80% of Students with Disabilities spend at least 80% of their day in the general education setting

The Office of Special Education is working with schools on this goal and has shared Standards of Learning (SOL) data showing that students with disabilities who spent most of their day in the general education setting with appropriate support made far more progress than students who receive their instruction separately.

## **APS Student Progress Dashboard**

The APS Student Progress Dashboard shows three-year trends and results of primary assessments including DIBELS (Dynamic Indicators of Early Literacy) and SOL pass rates, broken down by various demographics and schools. This has been updated with end-of-year results for 2022-23.

## **Academic Areas of Focus**

# Breaking Barriers for Student Success & Well-Being

- Use data to guide our work on how to best support students.
- Increase culturally responsive teaching, equitable practices, and individualized support to serve every student by strength and need.
- Instill a strong sense of urgency around the academic progress of individual students, students with disabilities (SWD), English Learners (EL) and Black and Latino students.





#### Math Update: Next Steps

Providing summer Content Academies (by level) focused on teaching and learning of new Mathematics standards

Revising of K-12 curriculum documents to reflect new standards, further embedding of EL resources to include instructional strategies, and revision of Extended School Year (ESY) summer resources

Creating additional professional learning for teachers on targeted research and evidenced-based Interventions

Moving Secondary Math Resources to stand-alone and "one-stop shop" Canvas Courses for the teaching and learning of new standards

**Engaging in parent-community information sessions (new standards and Math Pathways)** 

Working to develop more co-taught classes across the county to ensure equity in access for a diverse course selection for ALL students (contingent upon the results of the planning factor study)



## **APS to Provide ALL-In Tutoring**



The Virginia Dept. of Education has launched the All-In Tutoring Initiative for  $3^{rd} - 8^{th}$  grade students and continues to share updated guidance, providing school systems with increased flexibility with the implementation of high-intensity tutoring. APS has identified the students who are eligible for tutoring based on the guidance from VDOE.

#### Next steps

- Our schools are identifying students currently receiving intervention or remediation in school that meet the All-In Tutoring requirements.
- The Department of Academics is identifying resources already in place and additional resources needed to support tutoring.
- The Elementary and Secondary Directors of School Support are working with principals to develop tutoring schedules.

APS aims for tutoring to begin by mid-November as we finalize staffing and resource needs to best support students. Additional information will be shared as plans are finalized.

#### **Attendance Matters**

Attendance is important for academic success. To support your student:

- Finish homework and place it in backpacks
- Lay out clothes and backpack in the evening
- Have a regular bedtime routine
- Turn off electronic devices one hour before bedtime
- Let your student stay home only if they are sick
- Make every effort to schedule appointments after school hours
- Plan vacations when school is not in session

Chronic absenteeism, defined as a student being absent for 10% or more of the academic year, is now a factor determining whether a school should be accredited in Virginia.

#### Winter Weather Procedures for 2023-24

- Up to 13 Snow Days In the event of a weather event requiring school closure, APS will fully close for up to 13 days (based on the number of minutes available built into the calendar).
- Extended Day will close when schools close on Early Release Days.
- Decisions are **announced by 6 p.m.** the evening before the change when possible. If necessary due to an uncertain forecast, the decision is announced in the morning by 5 a.m.
- Full procedures and what to expect this winter season will be communicated to all staff and families next Wednesday.




#### **Arlington County Police Department MOU**

The Memorandum of Understanding (MOU) with ACPD has been updated to support student well-being and school safety.

#### **Updates include:**

- Clarifying when and how administrators must call ACPD for assistance
- Providing guidance for increased collaboration between ACPD and APS communications during a crisis
- Strengthening strategies for reunification during a crisis
- Providing increased opportunities for ACPD to support and have positive interactions with students

#### School-Based Behavioral Health Program MOU

#### Signed the week of **September 11**

- Affirms strong relationship between APS and the Arlington County Department of Human Services (DHS)
- Provides an agreement for DHS clinicians to provide behavioral health services in APS schools
- Four clinicians will be assigned to APS high school programs, in addition to the clinician already present at Carlin Springs Elementary
- Hiring is active for the high school positions with a goal of some clinicians beginning in October of 2023
